EXPRESSION OF INTEREST (EOI): PREQUALIFICATION FOR THE ELECTRICAL SUB CONTRACTORS

Brief description of the client

The Kenyatta National Hospital Staff Retirement Benefits Scheme (2011) was established in 2011 and operates on a defined contribution basis. The Sponsor, Kenyatta National Hospital (KNH), constituted KNH SRBS (2011) under an irrevocable trust for the purposes of providing pensions for members on retirement at a specified age and relief for dependents of deceased members.

Description of the project

KNH SRBS (2011) is looking for subcontractors interested in the construction of a phased residential scheme on part of its land, title number Kajiado/Kitengela/6242. The site is about nine [9] kilometres from Kitengela town, and about 400 metres off the Nairobi-Namanga Road. At completion, the first phase will comprise of 59No. four (4) and five (5) bedroom maisonettes and 30No. two (2) and three (3) bedroom apartments organized within 3No.blocks.

Notes to Interested Bidders/ Applicants

1. The purpose of this document is to assist the procuring entity KNH SRBS (2011) in the identification and evaluation of interested and qualified Contractors who may subsequently be invited to tender for the said works.
2. Interested bidders/applicants will be selected in accordance with the procedures set out by the procuring entity.
3. KNH SRBS (2011) reserves the right to verify the accuracy of the information provided herein. The interested bidders/applicants may be asked to clarify the information provided after close of the submission deadline.
4. This EOI does not amount to any contractual obligation on the part of KNH SRBS (2011), and the procuring entity is not obliged to invite tenders/quotation from any or all those who express interest by responding to this EOI process.
5. This EOI is restricted to interested bidders/ applicants registered for operations in Kenya. It shall be governed by Kenyan laws only.
6. The interested bidders/applicants must register with the procuring entity by sending an email to knhpension@knh.or.ke indicating the contact person, official email address and telephone number.

7. Interested bidders/ applicants will meet all cost associated with preparation and submission of their applications.
8. The interested bidders/applicants are advised to regularly check the procurement portal for any updates, amendments or clarifications.
9. All documents must be submitted in English language.
10. Where the interested bidder/applicant wishes to participate in more than one category; the interested bidder/applicant shall submit separate applications under each category (Building and Civil Works Contractors; Electrical Subcontractors; and/or Electrical Subcontractors).
11. No Consortium or joint venture (whether between two Main Contractors or between a Main Contractor and an Electrical and/or Mechanical Sub-Contractor or between Electrical and Mechanical Sub-Contractors) shall be allowed to participate in this EOI.
12. Interested bidders/applicants shall provide a paginated document with a Table of Contents. The document shall be intact, sequentially serialized and securely bound.
13. Interested bidders/applicants shall submit one (1 No.) original and one (1 No.) copy of the completed document.
14. The completed document SHALL NOT be submitted electronically.
15. Interested bidders/applicants may request for additional information or clarifications from the procuring entity through knhpension@knh.or.ke not later than five [5] days before the submission deadline. Any such response or clarification shall be uploaded on the portal for the access of all applicants.
16. The completed document shall be submitted following the outlined sequence on or before **14th April 2023 at or before 2.00pm** delivered to the tender box outside the office of the Director Legal Services, 1st Floor, Kenyatta National Hospital Administration Block, Nairobi. The documents shall thereafter be opened on **14th April 2023 at 2.00pm**.

Mandatory Requirements

1. Certificate of Incorporation.
2. Certified audited accounts for the last three (3) years.
3. Valid Tax Compliance Certificate.
4. Valid copy of National Construction Authority (NCA) Categories 1, 2 or 3 Registration Certificate for Electrical Works.
5. Current Annual Contractors Practicing License from National Construction Authority (NCA)
6. Valid Trade License or Single Business Permit.
7. Submission of valid CR12 form showing the list directors /shareholding (issued within the last 6 Months), a Certificate of Business Name Registration and National Identity Card for Sole Proprietorship.
8. A duly signed statement or declaration that : -
 - a. The firm has not been debarred from participating in any public procurement by PPRA.
 - b. The firm has not been engaged in any unethical, corrupt, collusive or fraudulent activities in public procurement matters.
 - c. The firm has not been declared bankrupt, insolvent or under receivership.
 - d. Declaration that the firm will not engage in any corrupt or fraudulent practice.
 - e. Declaration of litigation and arbitration history over the last five (5) years.
9. Evidence of having completed at least three (3) housing projects (maisonette units or apartment blocks), each with a minimum electrical works sub-contract sum value of at least Ksh. 50 million; OR having completed at least one (1) housing project (maisonette units or apartment block) with a minimum electrical works sub-contract sum value of at least Ksh. 150 million, within the last 10 years. (Provide Contract details, full list and contacts of the Client(s) and Consultants involved, Practical Completion Certificate, Letter of Award or Local Service Order).
10. Energy and Petroleum Regulatory Authority (EPRA) Class B

Bidders who do not meet any of the above will be disqualified and shall not be evaluated further.
